





Near- and zero-emission commercial vehicles cost-competitive and commercially viable in first-success applications and early-mover regions by 2025.






Zero-emission commercial vehicles dominate new vehicle sales by 2040.

Vivian Rahwanji, Director, Community Housing Development Corporation of North Richmond



Vivian Rahwanji serves as the Director of Transportation and Operations at Community Housing Development Corporation (CHDC) a non-profit in Richmond CA. She leads CHDC's Transportation Equity Project Driving Clean Assistance Program (DCAP, https://communityhdc.org/dcap/). For CHDC Operations, she develops and spearheads visionary, equity, and communication strategies to implement the California Air Resources Board's first Financing Assistance Incentive Project for low income and

disadvantaged communities. She serves as lead for the grant management, with a goal of accelerating EV usage, lending strategies specifically to priority populations to prevent predatory lending in their vehicle purchase, and education/financing assistance in priority communities. Our program is highly effective in promoting clean vehicles in communities that have been impacted by climate change and are more likely to be Black and Brown, as well as eliminated predatory lending that, again, disproportionately targets Black and Brown communities in our service offering. We work one-on-one with individuals to support them in making financial decisions that work for them and their families' needs. This includes financial coaching to support people with limited or challenged credit, high debt-to-income ratio, and people looking for reliable transportation. Vivian holds a Master of Arts degree in Management and Leadership from Liberty University in VA. and is a member of the Golden Key Honor Society.

Dan Sperling, Director, Institute for Transportation Studies, UC Davis



Dr. Daniel Sperling is Distinguished Blue Planet Prize
Professor of Civil Engineering and Environmental Science
and Policy, and founding Director of the Institute of
Transportation Studies at the University of California, Davis
(ITS-Davis). He holds the transportation seat on the
California Air Resources Board and served as Chair of the
Transportation Research Board (TRB) of the National

Academies in 2015-16. Among his many prizes and awards are election to the National Academy of Engineering in 2022, the 2018 Roy W. Crum award from TRB, its highest research award; and the 2013 Blue Planet Prize from the Asahi Glass Foundation Prize for being "a pioneer in opening up new fields of study to create more efficient, low-carbon, and environmentally beneficial transportation systems." He served twice as lead author for the IPCC (sharing the 2007 Nobel Peace Prize), testified 8 times to the US Congress, and provided 20 keynote presentations in the past year. He has authored or co-authored over 250 technical papers and 13 books, including Three Revolutions: Steering Automated, Shared, and Electric Vehicles to a Better Future (Island Press, 2018), is widely cited in leading newspapers, been interviewed many times on NPR radio, including Science Friday, Talk of the Nation, Marketplace, and Fresh Air, and in 2009 was featured on The Daily Show with Jon Stewart.
