### **SPECIFIC OFFENCE: ARTICLE 286 BIS OF THE PENAL CODE**



1. Any manager, administrator, employee or collaborator of a commercial enterprise or company who, either personally or through an intermediary, receives, requests or accepts an unjustified benefit or advantage of any kind, or an offer or promise to obtain it, for himself or for a third party, as consideration for unduly favouring another in the acquisition or sale of goods, or in the contracting of services or in commercial relations, shall be punished with a prison sentence of six months to four years, special disqualification from the exercise of industry or commerce for a period of one to six years and a fine of six months to four years and a fine of six months, or in the contracting of services or in commercial relations, shall be punished with a prison sentence of six months to four years, special disgualification from the exercise of industry or commerce for a period of one to six years and a fine of up to three times the value of the benefit or advantage.
